

A SUMMARY OF NEW FINDINGS FROM THE DOCTOR THESIS

5. New conclusions from the thesis:

In theory:

- The thesis systematized and clarified the concept. Characteristics of the new countryside, the content of the building of the new countryside.

- The thesis built up the theoretical frame about raising, allocating financial sources for building the new countryside, which was related to such matter as: analysing the nature, characteristics and interpreting the necessity of the participation of each source in building the new countryside; raising mechanism, financial allocation; the factors affecting the raising, allocating financial sources for building the new countryside.

In reality:

- The thesis generalized the natural, social-economic conditions and analysed the influence of such conditions on the raising, allocation of financial sources for building the new countryside; investigated Thai Binh’s actual status before the construction of the new countryside. The investigation was used as a basis to compare with the result of the five-year building the new countryside (2011 - 2015).

- The thesis analysed the status of raising, allocating the public and private financial sources for building the new countryside in Thai Binh province (2011-2015) based on the the secondary data and the result of the research. It also evaluated the achievements and limitation in raising, allocating the financial sources from different aspects: (i) legal basis for raising and allocating finance; (ii) scale, structure, and method of financial raising; (iii) allocating và using the financial sources; (iv) financial management; (v) supervising public investment. The thesis pointed out 6 objective causes and 6 subjective causes of the limitation of raising and allocating the financial sources.

- The thesis synthesized experience about raising and allocating financial sources for building the new countrysides in Nam Dinh, Hung Yen, Dong Thap and drew 6 lessons for Thai Binh province.

Suggestions drawn from the result of the research:

- The thesis proposed 6 ideas, 4 groups of solutions to improve the raising and allocating financial sources for building of the new countryside in Thai Binh (2016 - 2020). The suggested solutions for raising, allocating the finance in both public and private sources, which must be attached to the beneficiaries or the agents who have to take the responsibility to fulfill “social responsibilities” in the program of building the new countryside. The solutions were introduced in the time when many public laws were enacted and in effect.

- The thesis proposed some ideas to the government to make the solutions impossible. The proposals to the government center on the amendment, enactment mechanism and policies related to raising, allocating financial sources for building the new countryside.
